
Waterproof Requirements

Please waterproof cables in accordance with the following instructions. User shall assume all responsibility for device damage caused by water due to improper waterproof measures.



NOTE!

- Before you start, connect all the needed cables and cut off the copper wires for the cables that you don't use.
- Please use self-adhesive waterproof tape (supplied with some products) to protect the cables.
- Use waterproof components to protect the network cable. Waterproof the power cable separately if you don't use it. The video cable does not need waterproof treatment.
- Use insulation tape (not included in the package) to insulate the connection part of each cable.




- 2. Waterproof the cables with self-adhesive waterproof tape.
 - ${\rm (1)} \ \ \, {\rm Fully} \, \, {\rm stretch} \, \, {\rm the} \, \, {\rm waterproof} \, {\rm tape} \, \, {\rm at} \, \, {\rm both} \, \, {\rm ends}.$
 - (2) Wrap the connection part and the cable ends tightly with waterproof tape. Make sure the tape is fully stretched during the process.
 - (3) Tighten the tape at both ends to prevent water leakage.

3. Install the supplied waterproof components to the network cable in sequence.






CAUTION!

You need to mount the rubber ring onto the network cable interface first.

4. If your camera has a DC cable and you will not use it, insert the plug into the interface.



(Optional) After the waterproof treatment is completed, put the cables into a waterproof junction box (purchased separately).



CAUTION!

The cable connector must not be exposed and must be kept away from water. Restore and fasten the device after dismounting.

Place the power adapter in a power distribution box.

2 Safety Instructions

Installation and removal of the unit and its accessories must be carried out by qualified personnel. You must read all of the safety instructions before installation and operation.

2.1 Precautions

- When moving the device, do not use the tail cable to lift the device.
- When connecting to an external interface, use an existing connection terminal, and ensure that the cable terminal (latch or clamp) is in good condition and properly fastened.
- Do not overbend or drag cables during installation; otherwise, poor cable contact may cause malfunction.
- During installation, do not overbend the tail cables (including power cable and network cable).
- Make sure the device is always properly grounded.
- Do not aim the lens to any strong light source such as the sun or an incandescent lamp. It may cause permanent damage to the lens.
- To protect the front face from friction, scratch and stain, do not remove the protective film from the cover until mounting is finished.

- The temperature measurement device is recommended for indoor use. A closed and windless environment with constant temperature is preferred. The working temperature shall be 16°C-32°C, and the relative humidity shall be 90% or less.
- The installation environment should avoid entrance and exit, reflective objects like mirrors, air conditioning outlets and heat sources.
- The temperature measurement device should be used in a well lit environment.
 Use extra illuminators if necessary.
- When measuring temperature, a separation zone is required to guide people to the measurement device.
- When using the device indoors, if the indoor and outdoor temperature difference is great, reserve a zone to stabilize people's temperature.
- Make sure the length of the power cable between the power adapter and the camera is not too long, otherwise the voltage of the camera is lowered, causing the camera to work abnormally. If it is required to lengthen the power cable, lengthen the cable between the power adapter and the mains.



NOTE!

Please install the camera in strict accordance with the site survey and commissioning guide.


2.2 Maintenance

- If there is dust on the front glass surface, remove the dust gently using an oil-free brush or a rubber dust blowing ball.
- If there is grease or a dust stain on the front glass surface, clean the glass surface gently from the center outward using anti-static gloves or an oil-free cloth. If the grease or the stain still remains, use anti-static gloves or an oil-free cloth dipped with detergent and clean the glass surface gently until it is clean.
- Do not use organic solvents (such as benzene and alcohol) to clean the transparent dome cover.
- Make sure the cloth is clean itself.



4 Mount Your Camera

4.1 (Optional) Insert Micro SD Card

You need to install a Micro SD card first if you want to use the edge storage function.



NOTE!


- You need to format the Micro SD card before use. The Micro SD card can be formatted on the camera's Web interface.
- For recommended SD card specifications, please contact your dealer or technical support.

The figure below is for illustrative purpose only. The actual card slot position may vary.



WARNING!

- Before you insert or remove the Micro SD card, be sure to disconnect power and wait till the camera stops operation; otherwise, the camera or the Micro SD card may be damaged.
- Do not disassemble the device in high humidity environment. The high humidity inside the device will cause lens fogging.
- 1. Remove the 2 screws on the Micro SD card cover.
- 2. Insert the Micro SD card into the slot.
- 3. Check that the sealing ring is in position.
- 4. Put the back cover back in place, and turn the screws until they are fully tightened.




4.2 Wall Mount



NOTE!


- Concealed installation: Tail cables are routed through the wall.
- Open installation: Tail cables are routed outside the wall.
- Use the drill template and a Ø6-6.5mm drill bit to drill four 30 mmdepth holes on the wall.




Note:

For concealed installation, align the inner ring of the drill template with the guiding hole on the wall for wiring in step 6.


Mount the plastic rivets into the holes and ensure they are tightened up.




3. Use the screwdriver to loosen the screws on the camera base, then remove the junction box.




 (Optional) If you want to conceal the tail cables, cut the foam on the bottom of the junction box to allow the tail cables out.



5. Use screws to fix the junction box onto the wall.



6. Connect the safety rope in the junction box with the camera, then connect all cables.




Base guide hole

Side guide hole


Safety rope

 Loosen the hex fillister-head screws using a hex key, adjust the camera to desired monitoring direction, and then tighten the screws.






Base guide hole




3. Mount the pole-mount bracket to the appropriate position of the pole arm. Use the screwdriver to fix the junction box onto the bracket.




Connect the safety rope in the iunction box with the camera, then lead the tail cable through the guide hole.




Tighten screws to fix the camera onto the junction box

7. Adjust monitoring direction: Loosen the hex fillister-head screws using a hex key, adjust the camera to desired monitoring direction, and then tighten the screws.




4.4 Pole Mount (With Universal Joint)




NOTE!

The universal joint, pole-mount bracket, and loop are user-supplied.


1. Use the screwdriver to loosen the screws on the camera base, then remove the junction box.




(Optional) If you want to conceal the tail cables, cut the foam on the base of the junction box to allow the tail cables out.



- Mount the universal joint to the camera.
 - Loosen the screws on both sides of the universal joint, and then adjust the universal joint to the appropriate angle.
 - (2) Align the mounting holes at the bottom of the camera with the universal joint, and tighten them with two screws.



- 4. Mount the pole-mount bracket to the pole arm.
 - Attach the pole-mount bracket to the appropriate position of the pole arm, and then tighten the pole-mount bracket.
 - (2) Lead external cables through the pole and out from the pole arm.



Fix the universal joint with the camera onto the pole-mount bracket. Connect the tail cables with the external cables, and waterproof all cables. Adjust the camera to desired monitoring direction, and then tighten all screws.



5 Startup

After you have installed the device, connect to the power adapter(purchased separately) to start up the device.

6 Web Login

Log in to the camera's Web interface to perform management or maintenance operations.

The default network settings are shown in the table below and may be modified as required.

1 No live video after my first login?

Please turn off the firewall on your computer and then log in again.

2 How to restore factory default settings?

Remove the back cover, use a pointed object like a toothpick or paper clip to press and hold the RST button for 15 seconds to restore defaults.
