Waterproof Requirements


Please waterproof cables in accordance with the following instructions. User shall assume all responsibility for device damage caused by water due to improper waterproof measures.



NOTE!


- Before you start, connect all the needed cables and cut off the copper wires for the cables that you don't use.
- Please use self-adhesive waterproof tape (supplied with some products) to protect the cables.
- Use waterproof components to protect the network cable. Waterproof the power cable separately if you don't use it. The video cable does not need waterproof treatment.

1. Use insulation tape (not included in the package) to insulate the connection part of each cable.




2. Waterproof the cables with self-adhesive waterproof tape.

- (1) Fully stretch the waterproof tape at both ends.
- (2) Wrap the connection part and the cable ends tightly with waterproof tape. Make sure the tape is fully stretched during the process.
- (3) Tighten the tape at both ends to prevent water leakage.




3. Install the supplied waterproof components to the network cable in sequence.



CAUTION!

You need to mount the rubber ring onto the network cable interface first.

4. If your camera has a DC cable and you will not use it, insert the plug into the interface.



5. (Optional) After the waterproof treatment is completed, put the cables into a waterproof junction box (purchased separately).



CAUTION!

- The cable connector must not be exposed and must be kept away from water.
- Restore and fasten the device after dismounting.
- Place the power adapter in a power distribution box.

2 Safety Instructions

Installation and removal of the unit and its accessories must be carried out by qualified personnel. You must read all of the safety instructions before installation and operation.

2.1 Precautions

- Use a power adapter or a PoE device that meets requirements. Otherwise, the device may be damaged.
- Make sure the length of the power cable between the power adapter and the camera is not too long, otherwise the voltage of the camera is lowered, causing the camera to work abnormally. If it is required to lengthen the power cable, lengthen the cable between the power adapter and the mains.
- Do not overbend the cables during the installation, otherwise, poor cable contact may cause malfunction.
- When connecting to an external interface, use an existing connection terminal, and ensure that the cable terminal (latch or clamp) is in good condition and properly fastened. Ensure

that the cable is not tense during mounting, with a proper margin reserved to avoid poor port contact or loosening caused by shock or shake.

- During transportation, special attention is required to protect the transparent dome cover from friction, scratch and stain, etc. Do not remove the protective film from the cover until mounting is finished. Remove the protective film before powering on the device.
- Contact professionals for maintenance information. Do not attempt to dismantle the device by yourself. We shall not assume any responsibility for problems caused by unauthorized repair or maintenance.

2.2 Maintenance


- If there is dust on the front glass surface, remove the dust gently using an oil-free brush or a rubber dust blowing ball.
- If there is grease or a dust stain on the front glass surface, clean the glass surface gently from the center outward using anti-static gloves or an oil-free cloth. If the grease or the stain still remains, use anti-static gloves or an oil-free cloth dipped with detergent and clean the glass surface gently until it is clean.
- Do not use organic solvents (such as benzene and alcohol) to clean the transparent dome cover.

3 Appearance


3.1 Dimensions

- Type A




• Type B



3.2 Cables

The appearance and tail cable may vary with device model.



NOTE!

- For specifications, see the latest product datasheets.
- Press and hold the RESET button for at least 10 seconds to restore factory default settings. Perform this operation within 10 minutes after the device is powered on or the reset will fail otherwise.


4 Mount Your Camera

The illustrations below are for reference only. The actual device may vary.

4.1 (Optional) Insert the Micro SD Card

For cameras that support Micro SD, you need to insert the Micro SD card after opening the bottom cover of camera. Do not hot plug the Micro SD card after it is inserted. Otherwise the camera or the SD card might be damaged.




4.2 Wall Mount

You can adopt wall mount or ceiling mount and purchase hardware accessories by yourself. The following part takes wall mount as an example. Ceiling mount is similar to wall mount and therefore is omitted here.


1. Knock the plastic anchors into the guide holes and ensure that they are tightened up.




2. Screw the locknut to loosen the universal joint before attaching your camera to the wall.



3. Mount your camera onto the wall and connect all cables. Insert self-tapping screws through the guide holes in the base and fix them to the wall by using a screwdriver.




4. (Optional) Insert the antenna to the antenna interface according to direction.



5. Adjust the monitoring direction.

- (1) Adjust the opening of the universal joint as required.
- (2) Rotate the spherical hinge of the camera to get the desired monitoring direction.
- (3) Tighten the locknut.



6. Power on your camera and adjust images.

**NOTE!**

The preceding installation process is for concealed installation, during which holes are punched on the wall and cables are penetrated into the wall. If open installation is adopted, cables are not penetrated into the wall but threaded out from the outlet on one side of the base.

5 Device Management

5.1 Option 1: Manage on App

1. Connect your mobile phone to the **2.4GHz** Wi-Fi network.
2. Download and install app.



3. Connect the device to power.
4. Follow the on-screen instructions to add and manage the device.

**NOTE!**

If the red light/IR indicator flashes, it indicates the connection failed. Press and hold the reset button for about 10s to reset the camera and try again.

- The actual operations may be slightly different. Please follow the instructions in the app.
 - Do not connect the device with a network cable when managing on the app.

5.2 Option 2: Manage on Web

Before you begin, check that:

Your camera is operating properly and connected to the network.

Follow these steps to access your camera through the Web:

1. Open your browser, input the IP address (**192.168.1.13** by default) of your camera in the address bar and then press Enter to open the login page.
 2. Enter the username and password (**admin/123456** by default) and then click **Login**.

**NOTE!**

- DHCP is enabled by default. If a DHCP server is used in your network, your camera may be assigned an IP address, and you need to use the assigned IP address to log in.
 - You may need to install a plug-in at your first login. Please follow the on-screen instructions to complete the installation and then open the browser again to log in.
 - The default password is intended only for your first login. To ensure security, please change the password after your first login. You are strongly recommended to set a strong password of at least nine characters including all three elements: digits, letters and special characters.
 - If the password has been changed, please use the new password to log in.
